TERMS AND CONDITIONS

1. By entering this promotion, the participant understands and agrees that they will be legally bound by these promotional terms and conditions as well as the terms and conditions governing the use of Mobile Money Guyana Inc. (mmg+) service and platform.
2. It will be at mmg+'s sole discretion as to whether all eligibility requirements have or have not been met by the participant and may require evidence and/or confirmation from participants or any other source.
3. The participant understands and agrees that this promotion shall only be applicable to prepaid subscribers of the Guyana Telephone & Telegraph Company Limited ('GT&T'). For participants to benefit from this promotion, persons understand and agree that such persons must top-up their GT&T prepaid SIM Card by using mmg+'s web application, use of *123#, mobile application and/or mmg+ approved agents ONLY. For clarity, the Participant must only top-up their GT&T prepaid SIM Card through the methods identified above to benefit from this promotion. Once this is done, mmg+ will apply 1GB bonus data to the participant's account, at mmg+ sole discretion thereof.
4. In addition to Clause 3 hereof and subject to Clause 2, the Participant understands and agrees that to benefit from this Promotion, the Participant must top up at least one thousand Dollars (\$1,000.00) at one time. For any avoidance of doubt, if the Participant tops up less than \$1,000.00, the Participant understands and agrees that the Participant will not be eligible for this Promotion.
